Background/Course History:

Whereas in the past each other science course (Chemistry, Physics, etc.) had eliminated extra lab periods, Biology is the last science course to still include this extra .25 credit. Due to a combination of factors (including regular double block periods allowing for labs within the allotted time, shift toward NGSS standards, and limitations on ability to offer other science classes and electives), there is no longer a need for an extra lab period for Honors and Academic Biology.

Rationale for recommendation: (Vision, mission, standard, enrollment)

In addition to the explanation above of there no longer being a need to require extra lab periods, due to increasing graduation requirements, half of our students will need 9 credits of STEM based courses, and all students will need 3 of these credits in science in FY21. In addition to these credits we would like to provide more opportunities for students to take science electives, which have been limited due to staffing restrictions due to the extra .25
