Dear Scott:

We have reviewed the four bids received for this work on June 3, 2024, and find that the bid submitted by A. Lamp Concrete Contractors, Inc. is the lowest qualified bid at \$784,500.00. Jeff Moyer of A. Lamp stated that they included the propane tank and dispenser in their scope and this work will be done by Suburban Propane. Their unit prices of \$75/CY for excavation and removal of unsuitable soils and \$75/CY for import and placement of crushed granular base are acceptable.

The apparent low bid of \$671,300.00 submitted by Advantage Paving did not include the propane tank and dispenser as shown on the plans and specified in the RFI response. They also did not furnish an executed AIA A305 and were not willing to do so when contacted by our office. For these reasons, we recommend rejecting that bid.
