We would like to discuss the gymnasium lighting bid results for Cooper, Grant and Hayes Elementary School and the Ford Skill Center at the Building and Site Committee on Monday, May 21, 2012.

We discussed this project at our recent Building and Site committee meeting. We plan to replace the high bay metal halide light fixtures with fluorescent high bay fixtures and paint the ceilings in the gymnasiums at these four schools. We are recommending the low bidder for electrical and painting for a total as follows:
