<u>2025-02-7 Consideration of Approval to Authorize the District President or His Designee to Acquire Real Property, Negotiate, and Execute a Contract for the Purchase of Land in Collin County</u>

After discussion and on motion of Trustee Saad, and second of Trustee Wallace, this item was approved by a vote of 9-0 with up to 100% of the appraised value. Then, on motion of Trustee Menon, and second of Trustee Alexander, the motion was amended to remove any restrictions knowing that the 100% appraised value restriction is understood and the District President or his designee will bid up to the legal limit and have the best interest of the College and no publicized restriction on the approval. The amended motion was approved by a vote of 7-2. Trustee Gomel and Trustee Hardin were opposed to the amended motion.
