Ismael Mijares Deputy Superintendent for Business & Finance, addressed the Board and Superintendent and initiated the presentation of the 1<sup>st</sup> Budget Workshop. Mr. Mijares

reviewed with the Board the impact COVID-19 had this year's budget and what it will do for next year's budget. This year COVID-19 was very favorable. After March TEA did not require us to take attendance and they gave us the funds. Next year the first two six weeks (12 weeks total) we will be required to take attendance even though we will be in a grace period. If our attendance is lower than last year it will not count. If it is higher they will give us the funds for the higher attendance. He also reviewed the four District Funds categories as per TEA requirements, which are the (General Funds, Special Revenue Fund, Debt Services Fund, and the Capital Projects Fund). Most of the money comes from the State. The General Fund is used to account for all financial transactions except for those required to be accounted for in another fund. The General Fund maintains 20 subfunds. Among these 20 sub-funds are five that are new due to House Bill 3 (Dyslexia, College, Career, or Military Readiness Fund, Early Education Allotment Fund, School Safety Allotment Fund, State Test Reimbursement Fund), Special Revenues Fund maintains three (3) sub-funds, Debt Service Funds maintains one (1) sub-fund and the Capital Projects Funds maintains the Special Projects Funds.

TEA requires districts to post their budget (current and proposed) on their district website. Today's proposed budget will be taken to the Board on August 25, 2020 for approval. Also reviewed was the Tax Rate. House Bill 3 Part 2 makes us reduce our tax rate and TEA gave us the rate. The Proposed Tax Rate for 2020-2021 is 1.05.

Other budgetary matters included budget assumptions, proposed budget workshop schedule, additional request and other budgetary issues. **Board Members questions and concerns were addressed.**

Superintendent's Recommendations are as follows:

- 2 ½ increase for all other employees to include administrators, paraprofessionals, and manual trades
- The percentage (%) of professional's salary increases to include \$100-400 local step increase based on the 187 working day calendar at the average salary of \$61,282.00
- Local step increase for professionals is not state mandated and is not automatic, it is part of the overall salary increase which is approved at the discretion of the Board of Trustees
- The percentage (%) of salary increases for administrators, paraprofessionals, and manual trades is based on the midpoint of the employee's paygrade
- Salary increases will only apply to full time employees, part-time Food Service employees, part-time transportation employees, and other part-time employees who are eligible for fringe benefits and who have completed their 2019-2020 working calendar.
- New teacher starting salary \$49,000.00 for 2020-2021 School year

Vice-President Mrs. Martinez commented-To clarify there will not be no increase to the cost that our employees of the school district will have to pay in terms of their health insurance? Superintendent Mijares-Exactly, no increase

• In addition, no insurance premium will be increased.

Superintendent Mijares thanked the Board of Trustees for all that they do for our employees and for their support.

Board President Mr. Barrera, thanked all employees for all of their hard work.
