## COVID UPDATES

## Sanford Health and County Public Health Update.

### Sanford Health: COVID-19 Facts Over Fear

Dr David Wilcox and Kayla Winkler, from Sanford Health, reviewed the COVID-19 timeline. COVID-19 is not spreading in school. It is spreading in small groups in the community.

Sanford has increased COVID hospital bed capacity with progressive plans for making more beds.

### COVID Community Impact & Updates from Public Health

Megan Heuer and Cynthia Borgen, from Public Health, indicated COVID-19 spread is not happening in school. There are more cases in the community and long-term care facilities.

The community is urged to continue handwashing, social distancing, wearing masks, and manage chronic disease. More information is available on the Minnesota Department of Health and CDC websites.

## STUDENT REPRESENTATIVE REPORT

Joel Roberts and Abigail Enquist reported on Bemidji High School activities including fall sports; homecoming weeks; production of a student-made video urging the community to wear masks and social distance to help keep students in school; and the imbalance of A-week and B-week number of in-school days.

## EQUITABLE STUDENT ACHIEVEMENT

### Distance Learning Update

Colleen Cardenuto, Director of Curriculum and Administrative Services, indicated there are 951 elementary students enrolled in the distance learning model. There is a waiting list for elementary. At the quarter break we will allow more students into the distance learning model. At the secondary level, our teachers are teaching three models: seat based, at home and distance learning kids.

With the high number of students in distance learning, staffing has become an issue. We are limiting how kids move in and out because we have to shift staffing. As the COVID numbers change, people want to shift learning models.

The Rigor for distance learning has risen compared to last year. At the elementary level, we have kids log in with their live teacher most of the morning. The afternoon is reserved for project-based time. At the end of the day another optional log in time for students is available to ask questions or leave comments. Logging in daily is a must.

Superintendent Lutz indicated he has met with the COVID-19 Regional Support Team, public health, and Sanford Health and everyone is in agreement that we continue with the learning model in place. Research and data shows spreading is not happening in school if we follow safety protocols.

# Designation of Identified Official With Authority For the Minnesota Department of Education External User Access Recertification System

WHEREAS, MDE's External User Access Recertification System is a password protected website for members of educational organizations who have received prior approval to access statewide testing and graduation information. On behalf of Bemidji Area Schools, Tim Lutz is designated by the School Board as the Identified Official with Authority (IOWA) for Bemidji Area Schools for the secure site for Minnesota Department of Education Secure Systems information. This School Board action will be forwarded to the Minnesota Department of Education as a matter of record.

THEREFORE BE IT RESOLVED, the School Board of Independent School District No. 31, Bemidji, Minnesota, designates Tim Lutz, Superintendent of Schools, as the Identified Official with Authority with the Minnesota Department of Education for External User Access Recertification System related to the testing and graduation information of Independent School District No. 31, Bemidji Area Schools.

## Resolution Regarding Allowable Fund Balance Transfer for Fiscal Year 2019-2020

Ann Long Voelkner introduced the following resolution and urged its adoption:

## RESOLUTION REGARDING ALLOWABLE FUND BALANCE TRANSFERS FOR FISCAL YEAR 2019-2020

WHEREAS, Minnesota Laws 2020, Chapter 116/House File 4415, Article 3 Section 8, Subdivision 1, which stated in part:

"Section 8. FUND TRANSFERS; FISCAL YEARS 2020 AND 2021 ONLY. Subdivision 1. Fund and account transfers allowed. Notwithstanding Minnesota Statutes, section 123B.80, subdivision 3, for fiscal years 2020 and 2021 only, a school district, charter school, or cooperative unit may transfer any funds not already assigned to or encumbered by staff salary and benefits, or otherwise encumbered by federal law, from any accounts or operating fund to the undesignated balance in any other operating fund..."

WHEREAS, a fund transfer is allowed if the transfer meets the criteria set forth in Section 8 of Minnesota Laws 2020, Chapter 116/House File 4415, Article 3:

- 1. The transfer does not increase state aid obligations to the district or result in additional property tax authority for the district or charter school.
- 2. A transfer is limited to the operating funds of a district or charter school.
- 3. A school board must approve a fund transfer by the fiscal year reporting deadline.
- 4. A district or charter school must maintain accounting records for the purpose of this Executive Order that are sufficient to document both the specific funds transferred and use of those funds. Such accounting records are subject to auditor review.
- 5. Any execution of this flexibility must not interfere with or jeopardize funding per federal requirements.
- 6. Any transfer must not interfere with the equitable delivery of distance learning or social distancing models

WHEREAS, the School Board of Bemidji Public Schools, Independent School District 31, has determined that the criteria identified under Section 8 have been satisfied for a fund transfer pursuant to Minnesota Laws 2020, Chapter 116/House File 4415, Article 3;

WHEREAS, the School Board of Independent School District has reviewed and approved the attached *Request for Fund Transfer* 

THEREFORE, BE IT RESOLVED, that the School Board of Independent School District 31 authorizes the School District administration to submit the attached *Request for Fund Transfer*.
