The New Fairfield Board of Education held a special meeting on Tuesday, July 17, 2018, at 6:00 p.m. in the New Fairfield Board of Education Central Office Conference Room, 3 Brush Hill Road, New Fairfield, CT.

The Board asked about her role in working with the safety committee to upgrade district technology.

VII. COMMUNICATION

The importance of the Superintendent, District Administration and the Board working as a team was stressed. It was requested that the Board refer to the Superintendent and the Administrative team prior to addressing matters independently. A Board of Education and administrative team retreat may be planned. Good communication is very important. In response to BOE questions, the superintendent will respond to "all" with her answer. The Board will be notified of all incidents, and the Dr. Cosentino is considering sending a weekly "bulleted" update to the Board. The Board was reminded that topics discussed in Executive Session are confidential. It is important to measures the District's progress according to the Net Accountability Report and not just by test scores. The Board was encouraged to attend CABE conferences in August and November. It was requested that the Board have adequate time to review the budget before it is publicly presented.

VIII. UPDATE ON FIRST TWO WEEKS AS SUPERINTENDENT

Dr. Cosentino reported that she had a wonderful first two weeks. Paraprofessional mediation is scheduled for August 14th, and the start of teacher contract negotiations is planned for August 15th. Kathy Baker, Doug DeRito, Dominic Cipollone and Rick Regan have volunteered to serve on the teacher negotiations committee. Some district activities which are planned include book talks, team building exercises, professional development for administrators regarding the new teacher evaluation format and strategic planning meetings. Dr. Cosentino will present her goals to the Board at an August meeting and will share her goals with the staff at convocation, to which the Board is invited. She had attended two Safety and Security meetings, and plans on attend the July 18th Board of Finance meeting. Assessments will be reviewed on July 26th, and the first "Say Something" meeting is scheduled for that date as well.
