The report represents investments for the months of July 2015 - September 2015. The District's investments are governed by state laws and local policies. Every effort is made to maximize investment earnings while protecting the District's assets.

Mr. Harwell told Trustees as of September 30 the value of the District's total investment portfolio is approximately \$129 million dollars, which is down from about \$197 million on June 30. Reason for the decline are payments for bond construction, payroll, and other liabilities combined with a decline in the receipt of local tax collections which begin for tax year 2015 in October.
