President Knowles called the meeting to order at 7:00 p.m.

I. SUPERINTENDENT'S REPORT

Supt. O'Neill announced to the Board that he and Asst. Supt. Goss met with the Vicksburg Foundation and the Foundation granted VCS \$20,000 for a new digital sign for in front of the Vicksburg Administration Building.

Supt. O'Neill gave an update on Summer School which was very well attended at the secondary level. The elementary students are participating in a learning challenge this summer and earning charms for each level. It's been a big hit.

A. Staff Update

Supt. O'Neill gave an update on staffing for the 2024-25 school year.

B. Legislative Update

Supt. O'Neill stated that the final budget ended up being a disappointment. The mental health and school safety (31aa) allocation was greatly reduced. One positive aspect of the budget is the UAAL reduction of 5.78%. This is equivalent to almost \$380 per pupil.

C. Kindergarten Enrollment

There are 150 registered Kindergarten students and 32 BK students enrolled at this time.

A. Budget and Finance Report - Steve Goss

Asst. Supt. Goss presented the month budget progress report for June 2024 showing total revenue of \$31,707,216; total expenditures of \$33,134,421 and deficiency of revenue over expenses of \$(1,427,205).

Asst. Supt. Goss gave an update on the district's investment accounts.

C. Bond Construction Update - Steve Goss/Dewey Waterman

Maintenance Director, Dewey Waterman, gave an update on the construction in the elementary schools. The flooring replacement is going well. Many classrooms are painted. Bathroom renovations are ongoing. VMS will be getting new air handlers

installed on the gymnasium roof. VHS construction is progressing well and new ceiling equipment is being installed in each classroom. Dewey will provide an update to the Board at the next meeting.
