Purpose of Report:

The purpose of this report is to provide campus and district ADA percentages for the 4th Reporting Period of the 2018-2019 school year (January 7, 2019 through February 15, 2019) and to compare this data to prior years. This report will also identify current truancy prevention measures being used on Denton ISD campuses to increase student attendance.

Objective:

The objective is to routinely analyze and monitor Denton ISD's attendance data with the goal of improving student attendance. By making this data readily accessible throughout the school year, the district will raise awareness of school attendance and monitor trends and changes across the district. The district will also provide transparent communication, training, and support; where needed, to improve student attendance in Denton ISD.

Operational Impact:

The analysis and monitoring of attendance data will increase the funding received from ADA, increase academic success and school completion, and support the district goal ensuring that all students are reading on grade level by the end of grade 3.

Results:

There are 28 instructional days in this 4th Reporting Period. The district ADA% for 2018-2019 Reporting Period 4 is 95.17%, this is an increase from last school year when the ADA% was 94.0%.

Gonzalez and Ann Windle both serve EE and Pre-K students, their ADA % was 99.86% and 98.88%. Pecan Creek had the highest attendance percentage for elementary campuses in Denton ISD at 96.54%. Calhoun had the highest attendance percentage for middle school campuses in Denton ISD at 95.37%. Guyer had the highest attendance percentage for high school campuses in Denton ISD at 95.96%.

The previous school years ADA percentages are below:

Pre-K had the highest ADA% at 96.94%, followed by 9th grade with 95.99%. 12th grade had the lowest ADA% at 94.05%, followed by 6th grade with 94.60%.

The truancy prevention measures used in Reporting Period 4 include, but are not limited to; handouts, student and parent communications, campus consequences (882), referral to truancy classes (3248), warning letters (1938), attendance contracts (1598), home visits (27), Transport to/from school (8), referrals to truancy officer (121), contempt of court hearings (5) and referrals to court/court action (176). Denton ISD campuses have provided over **8,003** truancy prevention measures in this 4th Reporting Period.
