SUBJECT:

Approve the proposal submitted by Firetron Life Safety Solutions to perform a complete upgrade of the fire alarm system on the Wharton Campus at a cost of \$184,259.00 and \$4,000.00 for the needed cabling from a separate vendor for a total of \$188,259.00 with funds transferred from the Plant Repair & Replacement Fund.

RECOMMENDATION:

Approve the proposal submitted by Firetron Life Safety Solutions to perform a complete upgrade of the fire alarm system on the Wharton Campus at a cost of \$184,259.00 and \$4,000.00 for the needed cabling from a separate vendor for a total of \$188,259.00 with funds transferred from the Plant Repair & Replacement Fund.

BACKGROUND/RATIONALE:

The current Fire Alarm system was installed in 1999. It consisted of a Notifier AFP-200 fire alarm panel in each building along with pull stations, smoke detectors and horn strobes. It also included a Notifier AM 2020 as the main panel that all AFP-200's reported to and from there reported out to a monitoring company. All of these panels communicate with each using phone lines. The AFP-200 and AM-2020 are no longer being manufactured. Over the past years and on an as needed basis we replaced 4 of the AFP-200's with the new NFS-320. We are now proposing to replace the remaining 9 AFP-200's with the new NSF-320 (\$123,363) that will have an embedded gateway. This gateway will report back to a new Onyx workstation (\$34,577) that will replace the AM 2020. The existing 4 NFS-320 will have a gateway installed (\$9,148) that will allow communications with the new Onyx workstation. We are also proposing an upgrade to the La Dieu Building. It currently has a Thorn system that was installed in 1996. The upgrade will allow replacement of the Thorn system with the installation of the new NFS-320 and needed initiating devices (\$17,171). The work listed above will also allow us to move away from using phone lines. An additional \$4,000.00 will be needed to run the needed communication cables which will be contracted out separately from Firetron. Total cost of this project is \$188,259.00 using the TIPS-USA contract. Purchases under this contract satisfy all State of Texas bid requirements.
