- “1. Discussions about the decision of the United States government to designate the month of June as Gun Violence Awareness Month and to provide during the month of June an opportunity for individuals and organizations to educate communities on how to prevent gun violence;
2. Discussions about the decision of the United States Department of Homeland Security to publicly recognize that Scott Paul Beirele “was a racist and sexist person” prior to perpetrating a murder-suicide near the campus of Florida State University on November 2, 2018, and related matters;
3. Discussions about the denial of a federal FOIA request (FOIA Case No. 1531505-000) by the Federal Bureau of Investigation as a result of its refusal to deny certain claims made with respect to Scott Paul Beirele;
4. Discussions about publications by “Michael A. Ayele (a.k.a.) W” being “filtered and distorted” by internet search engines following his “decision to recognize” the responsibility of the United States Department of Justice and FBI in connection with various matters relating to the mass shooting perpetrated by Nicolas Cruz at Marjory Stoneman Douglas High School in Parkland, Florida, as well as the above-referenced murder-suicide perpetrated by Scott Paul Beirele;
5. Discussions about Florida State University and its reporting obligations with respect to a shooting perpetrated by Phoenix Ikner on April 17, 2025, and incidents involving Scott Paul Beirele prior to the above-referenced murder-suicide;
6. Discussions about the response of Florida State University to the above-referenced murder-suicide perpetrated by Scott Paul Beirele and whether such response created an environment where students, faculty and staff were encouraged to report instances of racism and sexism;
