# **SIGNIFICANT ISSUES:**

Full Filled Project, Inc. is responsible for following USDA and Texas Department of Agriculture policies and procedures to ensure program integrity. Full Filled Project, Inc. is responsible for preparing and delivering a nutritious meal or snack, which meets USDA nutrition requirements, to enrolled after school programs and participating summer programs. These meals or snacks are free of charge and Full Filled Project, Inc. is solely responsible for preparing the meals, delivering the meals, training site supervisors (personnel) directly involved with the meal service, and collecting required paperwork. Enrolled after school programs must meet after school during the school year and must meet qualification criteria.
