 - Absences General Information Statement if total absences
 - 2024-2025 If total absences per class, both excused and unexcused, exceed 10 for a semester, no credit will be allowed.
 - 2025-2026 If total absences per class, both excused and unexcused, exceed 10 for a semester, credit recovery will be required.
 - E. Truancy Students not reporting to assigned spaces in school or leaving assigned spaces without permission may also be considered truant. School-assigned consequences for truancy may include detention, restorative conferences, parent/guardian conferences, in-school suspensions.
 - Bullying <u>Anonymous Reporting Form</u> this will be posted on the district website as well and will be monitored by building principals.
 - Communication Devices/Cell Phones/Cameras/Earbuds/Headphones
 - Cleared up language for 5-8 expectations & 9-12 expectations
 - Middle School Students grades 5-8 will not be allowed access to their personal devices during the school day. Devices are to remain in lockers during the day.
 - High School Students grades 9-12 are not allowed to use these devices during class time, *including while out of the class on any pass*.
 - Credit Recovery
 - 2024-2025 The plan requires each hour over 10 in any given class to be made up. Make-up hours can be scheduled and served w/ the specific teacher or scheduled through the TPS (during detention, Learning Academy hours, or other optional time frames, etc.).
 - Make-up hours can be scheduled through the SEAL (Ross Resources staff) during detention, or other optional time frames, etc.
 - Dress Code

- 2024-2025 Hats, caps, or other head coverings except with the approval of the building principal (i.e., student undergoing chemotherapy, other medical situations or religious reasons). Upon entering the building, they should be removed.
- 2025-2026 While hats and other head coverings are generally permitted in school, individual classroom teachers retain the authority to establish expectations for their learning environment. Teachers may request that students remove hats or head coverings when appropriate for instructional or safety reasons. These classroom-specific expectations will be supported by school administration. Exceptions will be made for head coverings worn as part of a student's cultural, religious, or medical identity.
- Homecoming Candidacy Eligibility
 - 2024-2025 To be eligible for fall or spring homecoming royalty, students who have had any behavioral or chemical violations during their 9th-12th grade years, as defined by the MSHSL bylaws 205 & 206, regardless of their participation in an MSHSL activity will participate in 10 hrs of community service for each infraction, to be completed and verified by the activities office.
 - 2025-2026 For fall or spring homecoming royalty, students who have had any behavioral or chemical violations within the last calendar year, as defined by the MSHSL bylaws 205 & 206, regardless of their participation in an MSHSL activity will not be eligible for royalty candidacy.

 - School Security added "Due to safety and security concerns, students and visitors must identify themselves when asked by staff in the school building."

To volunteer in the school building or classroom, parents/guardians should contact the Principals' Office. Background checks may be required for volunteer opportunities at the discretion of the district.
