Topic	Essential Questions	Response
Analysis of Student Needs	Looking at current data, what needs are evident? Describe data source and identify needs.	We have reviewed current available data from a variety of district-level assessments from the 2024-25 school year. Assessment data indicates a significant need for targeted literacy and numeracy skills instruction specifically in vocabulary for ELA and fluency for both. Student growth is demonstrated via teacher observation, district level assessments and NWEA/ATLAS assessments; however, AYP has not been achieved by every student.

Individual Growth expectations will be set for each student by Sept 30th. 2. 70% of students will meet their targeted growth goals throughout the school year.

The areas of identified focus for this year are: ASL Instruction, Self-determination and Braille instruction, O&M instruction.

The needs of the students will continue to be monitored for growth in the Positive Behavioral Interventions and Supports (PBIS) system. Application of PBIS strategies within the Blind Department.

In May 2026, 80% of Students will report that school has a positive and welcoming learning environment. 2. As compared to August 2025, June 2025 student self-reporting of school- based bullying incidents in the previous 30 days will be reduced by 30%. 3. May 2025 parent survey will indicate at least 80% of participating parents reporting that the school climate is positive for their child.
