Regarding our conversations today, I would like to address the 3 contracts separately.

We assume you will only be keeping the AT&T services 2-3 months, therefore we wrote minimal contracts to keep any termination charges to a minimum.

Let's address the HVCP LD first. This is a \$600 annual commitment & you will not meet that commitment, therefore we do not recommend to enter into that agreement. The rates will stay the same until service is terminated & therefore there will be no termination charges expected in final billing

Regarding the completelink, we gave you the lowest commitment of \$1200 & you will meet that well within the 2 expected months of service, therefore there will be no termination charges expected in final billing.

Lastly, regarding the Centrex, as noted below, you will have a minimal termination charge because we only have a 2 line commitment on the revised contract. We anticipate approximately 131.60 (before any taxes/fess etc).

Of course, billing will not cease until services are fully ported. Any service still remaining with AT&T would of course bill at the contracted rate.

Let me know if you have any further questions. I will be out of the office Fri/Mon.

Also, I will forward you the CSR's you requested shortly.

So for example....if you use this for 2 mos, the term charges would be 26.32 / line x 2 lines (lowest commitment) x 25% X remaining months

10 mos. term charges approx.. 131.60 (before any taxes/fess etc)

Your local usage (completelink), Centrex & long distance all come up for renewal on 6/30/19.

It is always critical to keep these agreements in place to avoid much higher tariff rates. It can take a couple of billing cycles to get these in place, therefore would like to have these back as soon as possible

Including all agreements at 12 month terms as we discussed.

\* Complete link is a \$3,000 MARC (same as today) , net rate is \$32.34 (\$27.44 today) for POTS.- SENT LOWER COMMITMENT SEERATELY FOR \$1200

\* Centrex-kept the same rate \$11.91 per station

\* High Volume Call Plan (HVCP) \$50/month commitment - \$.045 per minute.

We have included the non erate riders for each service.

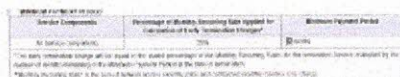

3. MINIMUM PAYMENT PERIOD

Service Components	Percentage of Monthly Recurring Rate Applied for Calculation of Early Termination Charges*	Minimum Payment Period
All Service components	25%	12 months

\*The early termination charge will be equal to the stated percentage of the Monthly Recurring Rates for the terminated Service multiplied by the number of months remaining in the Minimum Payment Period at the date of termination.

\*\*Monthly Recurring Rate<sup>2</sup> is the sum of network access monthly price and contracted monthly Centrex Line charge.
