Pursuant to 19 Texas Administrative Code §100.1035(c)(2)(A), the Texas Education Agency is required to provide notification to certain parties upon receipt of an expansion amendment request by a charter holder. This letter is to inform you that Somerset Academies of Texas (CDN 015830) intends to submit an expansion amendment request for consideration to the commissioner of education to add a new campus.

The proposed campus would be effective July 1, 2026. Its proposed location would be at 5415 North Loop 1604 East, San Antonio, Texas 78247. Somerset Academies of Texas is requesting to serve prekindergarten four-year-olds (PK4) through grade twelve (12), with a projected enrollment of 500 students at this location.
