Update for May 4, 2012

It's never dull around Lansing these days. As I said last week - we can expect May and June to be busy. Keep an eye out for possible upcoming alerts!

MPSERS

We expect a substitute version of <u>SB1040</u> to be introduced as early as next week. We are hopeful that some of the concerns raised during recent testimony will be addressed in the upcoming version. Stay tuned for more information.

Governor's Council on Educator Effectiveness

You may remember that PA102 of 2011 established the Governor's Council on Educator Effectiveness to determine an educator evaluation system and growth model for students, and that they were supposed to report their findings to the Legislature by April 30, 2012. Well, last week the Michigan Council for Educator Effectiveness (their new name) issued their Interim Progress Report.

A timeline with their recommendations -

June 2012

- Determine up to 3 observation tools to be used for a pilot
- o Release details for a 12 district pilot for 2012-13 school year
- July 2012
 - o Release other components of teacher evaluation system
- October 2012
 - Determine student growth model
- November 2012
 - o Determine evaluation tool for school administrators
 - Release details regarding the pilot for administrator evaluations
 - Release district waiver processes and principles
- April 2013
 - Professional certificate
- June 2012
 - Review all recommendations and adjust based on new data and info

Kindergarten Entry Age Change

This week the Senate passed <u>SB315</u> & <u>316</u> sponsored by Sen. Darwin Booher (R-Evart). The bills would phase-in a change in the kindergarten age requirement beginning in the 2013-14 school year.

- 2012-13 age 5 by December 1
- 2013-14 age 5 by November 1
- 2014-15 age 5 by October 1
- 2015 and beyond age 5 by September 1

An amendment allows parents to notify school districts by June 1, if their child will be age 5 by December 1 that they intend to enroll their child in the upcoming kindergarten class. (By August 1 if a new resident) Although the school can advise a parent that the child may not be ready, the final decision to enroll the child rests with the parent.

The bill now moves to the House Education Committee. Given that <u>HB4513</u> & 4514 mirror the Senate version with the exception of the waiver (2 year limit in the House version), it is likely the House will move quickly on the bill package.

Cyber Schools Expansion

After weeks of holding off the vote, the expansion of cyber schools in Michigan is one step away from being a reality. <u>SB619</u> introduced by Sen. Patrick Colbeck (R-Canton) is on its way to the Governor for his signature. The bill did undergo a number of changes as it made its way through the legislative process.

Highlights of the bill includes:

- Through December 31, 2013 a limit of 5 cyber charter schools with a maximum of 2,500 students each
- Through December 31, 2014 a limit of 10 cyber charter schools with a maximum of 5,000 students each
- After December 31, 2014 a limit of 15 cyber charter schools with a maximum of 10,000 students each

Why Should the PPT Reform Be Important to You?

The Senate Finance Committee approved a package of eight bills <u>SB1065-1072</u> which would phase out the personal property tax (PPT) for industrial properties, as well as provide an exemption for small commercial properties.

This seemingly unrelated proposed legislation is a great example of why local units of government (including school districts) have significantly lower amounts of revenue these days. The passage of these bills could cut state and local revenue by \$600 million by 2012-22 according to the Senate Fiscal Agency.

Data available suggests that residents of over 400 local districts will see local property tax increases to sustain local bond project payments as a result of the bill package. In addition, ISDs that levee operating millages will see reduced annual revenues.

School groups have advocated for guaranteed replacement funds each and every time tax changes reduce available revenue for schools. This time the local municipalities have joined the fight. Although the proposed language creates a fund to reimburse a portion of the loss, the fund has no guaranteed revenue itself. Not much of a guarantee!
