

RESOLUTION APPROVING CHANGE IN ATTENDANCE CENTER BOUNDARIES

WHEREAS, the Board of Education of Harvey Public School District No. 152, Cook County, Illinois (hereinafter “Board”) owns and oversees nine elementary school buildings; and

WHEREAS, the Board has by resolution authorized the closing of Lowell Elementary School; and

WHEREAS, the closing of Lowell Elementary School has necessitated a change in the attendance center boundaries of the district;

WHEREAS, the Board is authorized under Illinois law to establish attendance centers (105 ILCS 10-21.3); and

WHEREAS, the Board has the power to assign pupils to the schools in the district (105 ILCS 10-22.10)

WHEREAS, the Board has heard the reports and recommendations of its administration regarding the change in attendance center boundaries resulting from the closing of Lowell Elementary School; and

WHEREAS, the Board hereby finds that it is necessary and in the best interests of the School District to change the attendance center boundaries in accordance with the changes set forth in Exhibit A, attached hereto as Exhibit A and incorporated herein by reference, effective at the conclusion of the current 2016-2017 school term.

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of Harvey School Public District No. 152, Cook County, Illinois as follows:

1. That the foregoing recitals are hereby incorporated by reference.
2. That the Board hereby authorizes, approves and directs the changes in attendance center boundaries as set forth in Exhibit A, specifically:

- A. That students residing in the geographic area bounded by 155th Street to the North, 157th Street to the South, Ashland Avenue to the West and the Illinois Central Railroad tracks to the East, shall attend Whittier Elementary School, commencing with the 2017-2018 school year.
- B. That students residing in the geographic area bounded by 157th Street to the North, 162nd Street to the South, Ashland Avenue to the West and the Illinois Central Railroad tracks to the East, shall attend Maya Angelou, commencing with the 2017-2018 school year.
- 3. That the Superintendent is authorized and directed to take any and all steps and pay any and all costs necessary to effectuate the changes in attendance center boundaries.
- 4. That this Resolution shall be in full force and effect immediately upon its adoption.
