RATIONALE/DISCUSSION:

As part of the review of business services, request for proposals for beverage services have been reviewed by a committee. The committee was represented by myself, as Director of Business Services, Becky Nino, Administrative Assistant for Business Services and Ana Gonzalez, PHS Principal. Four proposals were received and reviewed by the committee. The four beverage service companies were Pepsi, Lyons Vending Service, Courtesy Vending Service and Coke. The proposal from Coke was disqualified because of lack of information and did not meet RFP criteria.

These are services that impact the district financially as well as implement board policies and goals. Part of the proposal process is to determine the best pricing along with service.

Evaluation is based on services that the vendor provides along with pricing. A request for proposal is different from a request for bid that is based on price alone. A proposal also evaluates the services provided. However, price or cost of services has a heavy weighting on determination of services. The committee recommends that Courtesy Vending Services be designated as provider for beverage services at Parkrose High School effective July 1, 2010 through June 30, 2015.

FINANCIAL IMPLICATIONS:

The proposal from Courtesy Vending Services meets expectations of services, commissions and cost for District beverage vending needs.

RELATION TO GOALS:

This information supports District policy to form business partnerships as well as good fiscal management practices.

ACTION REQUESTED:

Resolution to designate Courtesy Vending Services to provide beverage vending services at Parkrose High School effective July 1, 2010 through June 30, 2015.
