### **Opening and Call to Order**

## **Approval of Board Agenda**

Chris Fritsch shared the MOU between the district and the CTUIR. Gary George stated that the MOU needs to be updated with specific dates so that we can continue to keep up with any changes. Mr. Fritsch pointed out that the new Federal Impact Aid Policy is consistent with the MOU.
