The policy does not provide or replace individual, family, or group healthcare insurance coverage. The district policy is accident only, not sickness and illness. The supplemental accident policy pays after the parent's primary insurance policy. If the parents do not have primary insurance, then this policy pays as primary insurance. Included in the coverage are also riders for football and catastrophic. Texas Kids First has been a good partner and served the district well. The Board Approved renewal of Texas Kids First in 2015 & 2017 at the same rate of \$34,46. Texas Kids First is offing a two year rate guarantee for accident and catastrophic coverage at the same price of \$34,460.00 It is my recommendation the Bellville ISD Board of Trustees approve the renewal/rate guarantee contract with Texas Kids First for Student Athletic and Activity Insurance.
