The New Fairfield Board of Education held a regular meeting on Thursday, April 4, 2019, at 7:00 p.m. in the New Fairfield Community Room, 33 Route 37, New Fairfield, CT.

- I. CALL TO ORDER: Chairman Peggy Katkocin called the meeting to order at 7:00 p.m.

IV. APPROVAL OF THE AGENDA

MOTION: Peggy Katkocin made a motion to approve the agenda with the addition of Action Item F "Owner's Representative for Consolidated School/New Fairfield High School Building Study." Dominic Cipollone seconded the motion. **IN FAVOR:** Kathy Baker, Dominic Cipollone, Greg Flanagan, Peggy Katkocin, Kimberly LaTourette, Samantha Mannion, Rick Regan, Ed Sbordone and Stephanie Strazza

MOTION: Rick Regan made a motion to table Information Item B "Next Generation Accountability Presentation" until after the Curriculum subcommittee review on April 29th. V. PUBLIC PARTICIPATION

Consolidated School Second Grade teacher Kathy Curran spoke of her concerns regarding the proposed increase in class sizes for next year for the Consolidated School classes.

Nikolas Karloutsos noted that he and his wife have been very happy with the quality of education that his children have received so far and the wonderful strides that his daughter has made in the ELC program, but spoke of his concerns of the possible increase in class sizes for next year.

Jim Mellett spoke of the proposed high school textbook *The Living Earth: Integrating Biology and Earth Science*. He further gave an update of the Association of Retired Scholars and noted that they would like to help students with understanding climate change in the early grades. Brian Eglinton gave his opinion regarding emails that he received from administrators. Amanda Lombard noted her concerns about the possible increase in class sizes at Consolidated School.

BOE member Kathy Baker spoke as a parent in the school system regarding her concerns with vaping in the high school.

VI. BOARD AND ADMINISTRATIVE COMMUNICATIONS

- A. <u>Chairman's Report</u> Peggy Katkocin spoke of the following:
 - The BOF voted to send a proposed tax increase of 1.05% to a Town Meeting which will then go to a referendum. She commended the BOF, BOS and BOE for their ability to work so well together. She noted that voter turnout has been low in recent years and encouraged residents to vote.
- B. <u>Superintendent's Report</u> Dr. Pat Cosentino spoke of the following:
 - Mini K Parent Night was held at Consolidated School on April 3rd. She thanked the Consolidated School staff for all their work with this night.
 - Math Night at the high school was held on April 4th.
 - Paraprofessionals were honored yesterday on Paraprofessionals Day.
 - There will be a "Dollar Dip Dinner" on April 5th at the high school cafeteria to support the Academic Decathlon.
 - Flyers have gone out for the Summer Enrichment Camp in New Fairfield that will run from June 24th to July 25th.
 - Kara Mehler, Karen Fildes and Keegan Finlayson went to UConn to recruit upcoming UConn graduates to join the New Fairfield staff.
 - Dr. Cosentino will be going to Finland in August with CCSU to learn about Educational practices in Finland. She gave a brief description of her itinerary.
 - Dr. Cosentino along with Peggy Katkocin, Ed Sbordone, Phil Ross, James D'Amico and Rich Sanzo attended a meeting with DAS (Department of Administrative Services) in Hartford. Dr. Cosentino spoke of the possibility of making the June 30th deadline for grants. It was noted that applications can only be sent once a year by June 30th. She spoke of the possibility of state reimbursements for the rebuilding of Consolidated School and New Fairfield High School. She spoke of the many building issues with both schools and the facilities study done by architects QA&M. Different options for these projects include renovation of the schools, repairing various issues or rebuilding new schools.

Dr. Cosentino noted that the State was very clear that they will not give reimbursements to renovate the schools as they are now. Instead, Dr.

Cosentino spoke of the possibility rebuilding a new high school and Elementary school. She gave preliminary ideas for both schools. Dr. Sanzo spoke of the timeline for this and important information that should be considered. He noted that this will be discussed at the April 9th and April 23rd meetings.

C. Student Representatives' Report

Senior Representative Hannah Rigoglioso reported on the following:

- Incoming Principal James D'Amico was introduced to the staff today.
- The PSAT/SAT will be given on April 9th for 9th, 10th and 11th graders.
- Spring sports have started and there will be a Pep Rally on April 12th.
- Academic Decathlon will go to Nationals in Minnesota. There will be a "Dollar Dip Dinner" on April 5th at the high school as a fundraiser to help send the students to Nationals.
- The Girls' Lacrosse team was on the front page of the *Danbury News Times*.

- 1. <u>Curriculum</u> Kim LaTourette noted that the Curriculum subcommittee met on March 25th. High School teachers Keegan Finlayson and Jean Gephart presented a new Biology textbook, *The Living Earth: Integrating Biology and Earth Science*.
