WHEREAS, the Town of Horizon City has undertaken a project commonly referred to as

Municipal Facilities Phase I (the "Project");

WHEREAS, the Town of Horizon City entered into an Interlocal Agreement between

the Horizon Regional Municipal Utility District ("HRMUD") and the Town of Horizon City

dated August , 2024 for reimbursement of actual design expenses in connection with the

construction of a sewer service line to be installed as part of the Project (the "Interlocal

Agreement");

WHEREAS, the Town of Horizon City has requested the HRMUD also assist in the design

of the water service tie-in necessary to provide water service to the Project; and

WHEREAS, the HRMUD has agreed to allow their engineers to design the water tie-in

service if the City will reimburse the HRMUD for the actual cost of the design;

WHEREAS, the City and the HRMUD have decided to amend the Interlocal Agreement

to allow for the design and reimbursement of the water service water tie-in.

WHEREAS, in order to avoid delaying the completion of the Project it was necessary for

the Mayor to authorize the commencement of pre-construction work by the HRMUD engineers

and City staff and to sign the First Amendment to the Interlocal Agreement before the December
