

Maywood-Melrose Park-Broadview School District 89 eRate Status Report June 2012

2011-2012 actually saw visible progress in the acquisition of eRate Funds to the District. Though at this time we are still behind in funding, it appears that we will catch up in 2012-2013.

We have passed through the selective review process that has taken nearly two years. The program has become stricter and many rules must be followed exactly to get funded.

The District 89's history is shown on page two. Years 2009, 2003 and 2001, highlighted in yellow, show no filings for funding. Years 2008, 2006 and 2002, highlighted in green, show no requests to the vendors to get paid though funds were granted. Lastly years 2007 and 2000 show lack of persistence to vendors to acquire funds and send to the district. We are now in the process to make sure all vendors file necessary paperwork for 2010-2011 and submit reimbursement checks.

Two schools that have similar economic climates and continue to experience challenges with eRate filings, Bellwood and Proviso High Schools, are illustrated in pages 3-4. Note the important column is "Total Disbursed" vs "Committed Priority 1" and "Remaining Balance."

Funding Analysis for 2012, 2011 and 2010 are included in pages 5-7 show what to expect from our telecommunication vendors in the short term.

Finally, our current application status for 2011 and 2012 can be found on pages 9-10. We are out of selective review and 2012 is ahead of 2011 in the process.
