

## SEVENTH AMENDMENT TO SERVICE AGREEMENT

THIS SEVENTH AMENDMENT TO SERVICE AGREEMENT (the "Seventh Amendment"), effective as of July 1, 2025, is made by and between Board of Education of Roselle School District No. 12, DuPage County, Illinois ("District") and ABM Education Services, LLC, as successor in interest to ABM Industry Groups, LLC ("Contractor"). Contractor and District are hereinafter referred to as the "Parties" to this Seventh Amendment.

## RECITALS:

- A. WHEREAS, the Parties have entered into a Service Agreement dated July 1, 2016, which was previously amended effective July 1, 2019, July 1, 2020, July 1, 2021, July 1, 2022, July 1, 2023, and July 1, 2024 (collectively referred to as the "Agreement"), whereby District retained Contractor to perform various services specified in the Agreement itself; and
- B. WHEREAS, the Parties desire to make certain modifications, revisions and amendments to the Agreement itself.

NOW, THEREFORE, for and in consideration of the mutual promises and undertakings herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties state and agree as follows:

- 1. <u>Assignment.</u> ABM Industry Groups, LLC, hereby assigns the Agreement, as amended, to its affiliate company, ABM Education Services, LLC, and the District, by executing this Seventh Amendment, hereby consents to this assignment; and hereafter ABM Education Services, LLC shall be the successor in interest to ABM Industry Groups, LLC in relation to the Agreement.
- 2. <u>Term.</u> Pursuant to Section 2 of Agreement, the parties mutually agree to extend the Term of the Agreement, which extended term shall commence as of **July 1, 2025** and terminate **June 30, 2026** (the "Term"), unless sooner extended or terminated as provided in the Agreement.
  - 3. Pricing. The parties mutually agree to a price modification as set forth in Attachment A below.
- 4. <u>Ratification</u>. Except as and to the extent amended, altered, and/or modified as provided in this Seventh Amendment, all terms, covenants, conditions, and provisions of the Agreement are hereby ratified and reaffirmed, and shall remain in full force and effect.
- 5. No Default. The Parties hereby acknowledge and agree that, as of the date of this Seventh Amendment, neither party is in default or otherwise in breach of the Agreement, and to their best knowledge no facts exist which, with the passage of time, the giving of notice, or both, could become a default or breach of the Agreement.
- 6. <u>Counterparts</u>. This Seventh Amendment may be executed in one or more counterparts, and exchanged via facsimile or other electronic transmission, each of which shall for all purposes be deemed to be an original and all of which shall constitute one and the same instrument.
