#### **Executive Summary**


- The total utility cost for the July 2013-December 2013 period, increased by \$64,491 (1.8%) compared to the prior year for the existing facilities as of FY 2012-2013. New schools (Myers) added an additional \$111,512 to the Denton ISD utility budget for this time period. Other than the increase usage in gas due to a (44.9%) increase in heating degree days, the increase is due to increased rates in electricity, natural gas and irrigation.
- 2) The utility usage for the July 2013-December 2013 period compared to the prior year is a follows:
  - a) Electric usage decreased by 4.8%
  - b) Natural gas usage increased by 22.0%
  - c) Domestic water usage increased by 3.8%
  - d) Irrigation usage decreased by 21.0%
- 3) Utility rates increased for electricity, natural gas and irrigation, resulting in an increase in cost of \$187,198.
  - a) Electric unit cost increased by 6.4%.
  - b) Natural gas unit cost increased by 3.6%.
  - c) Domestic water unit cost decreased by 0.1%.
  - d) Irrigation water unit increased by 9.7%.
- 4) Weather
  - a) There was a 3.7% decrease in the number of cooling degree days, and a 44.9% increase in heating degree days.
  - b) Rainfall in this period increased by 5.36 (61.3%) inches.


### **Utility Costs Comparison to Prior Year**


