# **BOARD AGENDA ITEM Board of Trustees Meeting July 24, 2018**

Consider Approval of 2018 – 2019 Pre-Kindergarten Waiver of 210 Minutes School Day

## **SUMMARY:**

This consent agenda item requests approval to apply for a 2018 – 2019 Pre-Kindergarten Waiver of 210 Minutes School Day from the Texas Education Agency (TEA). As allowed by TEA and in accordance with HB 2610, pre-kindergarten programs that offer less than a 210 minute school day, but offer at least 2 hours (120 minutes) of instruction per day are eligible to submit a one-time waiver.

The Denton ISD pre-kindergarten programs provide 180 minutes of instruction in the half-day programs. The half-day pre-kindergarten program in the Denton ISD allows for 90 minutes of language arts instruction, 50 minutes of mathematics instruction, 20 minutes of science and/or social studies instruction, and a 20-minute recess. It is important to note our half-day pre-kindergarten programs are separate and apart from our HEAD Start program, which allows for a full day of instruction.

Academic Programs, together with the Coordinator of Early Childhood, will monitor developing legislation related to instructional minute(s) requirements of the state of Texas pre-kindergarten programs and will adjust start/end times for the 2018 – 2019 school year, if necessary.

In consideration of the requirements set forth in HB 2610, half-day pre-kindergarten programs must have a total of 37,800 minutes since pre-kindergarten is funded on a half day of ADA. Without approval and submission of the 2018 – 2019 Pre-Kindergarten Waiver of 210 Minutes School Day, ADA and FSP funding calculations may be impacted.

#### **BENEFIT OF ACTION:**

Approval of this action allows the District to submit a 2018 – 2019 Pre-Kindergarten Waiver of 210 Minutes School Day, to waive the HB 2610 instructional minutes requirement in calculating ADA and FSP funding for our pre-kindergarten programs.

# PROCEDURAL AND REPORTING IMPLICATIONS:

Texas Education Agency will process the formal request as approved by the Denton ISD board of trustees.

#### **ALTERNATIVES:**

Without consent of approval to submit the 2018 - 2019 Pre-Kindergarten Waiver of 210 Minutes School Day, the average daily attendance for our pre-kindergarten programs will be utilized in determining ADA and FSP funding calculations, having a negative impact to overall funding.

The Superintendent recommends the Board approves the 2018 – 2019 Pre-Kindergarten Waiver of 210 Minutes School Day request to be submitted for consideration to the Texas Education Agency.
