The Board of Education authorized the pilot temperature control project going out to bid and it was recommended by the District's architectural firm, STR Partners LLC, given the necessary lead time, that these units, along with the elevator at Whittier School, be let early as a pre-purchase package. The appropriate legal notice calling for both of these projects appeared in the January 29, 2014 issue of the Wednesday Journal (see attached copies of bid notices) with a bid opening date set for Thursday, February 20, 2014 at 10:00 a.m.

With the movement of two Early Childhood classrooms from Holmes School to Whittier School and the need to move the existing Art Room (conversion to two Early Childhood classrooms) at Whittier to the second floor, an additional three unit ventilators needed to be acquired, thus making the total number of units 26. The additional Early Childhood classrooms are being funded through IDEA and Medicaid funds.

On Thursday, February 20, 2014, three bids were received (attached is a summary of those three bids). Also attached is a letter from STR Partners LLC recommending award to Midwest Applied Solutions, Inc., in the total amount of \$244,780 for the 26 units. Jennifer Costanzo is unable to be at the meeting on Tuesday evening; however, Norm will be there and he has worked closely with both Jennifer and the mechanical engineer and should be able to respond to any questions raised. However, if Board members do have questions prior to Tuesday evening, perhaps they could share with you and I can provide answers at the meeting Tuesday evening.
