involved families.

Students could help organize and clean our storage area that contains tangible items for foster and adoptive	
homes. They could help with events and fundraisers by setting up or cleaning up. They could send thank you cards to donors or help design social media posts or mailings. Students could also help outside the Support	
Center by picking up trash, throwing away old toys or doing yard work. If the student has a vehicle, they could deliver adoption gifts or tangible items to families.

Students would be working directly with our staff and approved volunteers so they would be under supervision while at our facility. Our work with DCFS requires us to follow all state laws regarding the safety of children and families while at our center.

With 1 in 50 children and youth in foster care in Sebastian County, these students will likely be serving, indirectly, the very kids that they go to school with. It is unlikely that will meet or know who these kids are as we work directly with the foster and adoptive families however, I think it is important to note and could lend more meaning to their work. Especially, if they are doing something like writing a thank you card or weeding a flower bed, it may not directly serve their peers but indirectly, they are making a huge difference in another student's life.
