## July 29, 2008 FY09 BUDGET PUBLIC HEARING

## III. FY08 BUDGET HEARING

Superintendent Randy McCoy presented the proposed 2008-2009 Tupelo Public School District Budget. The total anticipated revenue for 2008-2009 is projected to be \$80,308,435.47 and the total expenditures for the 2008-2009 school year are budgeted at \$87,574,180.95.

A copy of the proposed budget is marked EXHIBIT 1 and included in the Exhibit Book of this meeting date.

At this point, Dr. Tutor opened the meeting for questions from the floor by explaining that each individual would be allowed to ask one question at a time on a rotating basis until all participants had the opportunity to present a question or make a statement.
