We propose to furnish and install a Denton ISD standard; Tridium Niagara based HVAC, Access, and Irrigation control system for the new Middle School #7, per plans and specs dated February 27<sup>th</sup>, 2012.

## HVAC Controls for the following:

- (8) condenser water pump packages with (2) pumps each with associated valves and devices
- (8) Energy Recover Ventilators
- (2) Domestic Water Preheat Heat Pumps
- (24) Rooftop Water Source Heat Pumps
- (92) Horizontal Water Source Heat Pumps
- (8) DX Split Systems
- Miscellaneous points including:
  - a. (6) additional space sensors for monitoring and control in the office area
  - b. (1) Modbus integration to the main electrical gear for KWH usage and tracking
  - c. (1) Gas Meter pulsed input for monitoring usage
  - d. (1) Domestic water pulsed input for monitoring usage
  - e. (1) each Outside air Temperature and Humidity
  - f. (8) Electric unit heaters (monitoring only)
  - g. (1) Gas unit heater (monitoring only)
  - h. (6) Exhaust Fans (control and monitoring)
  - i. (11) Thermostats for exhaust fans
  - j. (3) points for Exterior Building Security Lights
  - k. (3) points for Exterior Pole Lights

- 6. Smoke detectors are excluded
- 7. Testing and balancing are excluded
- 8. Space sensor back boxes and conduit stub-ups are excluded
- 9. Performance and payment bond.
