BACKGROUND INFORMATION: The Aledo ISD SHAC consists of 28 members and began meeting in October 2012. The committee met a total of four times during the 2012-2013 school year. Each year, the SHAC committee is charged with the responsibility for making a formal report to the School Board summarizing the committee's activities for the year. Below is a synopsis of the committee activities for the 2012-2013 school year.

 - Welcomed new members

 - Viewed and approved the video, "Human Body in Action: Reproduction and the Endocrine System"
 - Patty Willhite shared the new USDA calorie guidelines for school meals and how the guidelines affect food offerings for students
- December 3, 2012
 - Unanimously elected Diane Taylor to serve as the parent co-chair
 - Reviewed AISD SHAC Constitution
 - Scott Kessel shared anti-bullying video used to train all AISD employees, including DCS bus drivers, parents, and students during the months of August- October
 - Viewed links to new District anti-bullying resources located on School Fusion
 - Viewed link to anonymous bullying report system located on School Fusion
- February 4, 2013
 - Viewed presentation from Leukemia/Lymphoma Society a fund raiser was conducted by the Vandagriff campus to support their student without including the student education portion of the program
