Qualified children with disabilities have a right to a free appropriate public education under Illinois and Federal law. School district and public agency screening is available to identify possible disabling conditions in children ages 0-21 to determine the need for special services prior to, and while enrolled in school. Mid-Valley Special Education Cooperative, and its member districts, Community Unit School Districts 101, 301, 302, 303 and 304, offer a variety of special services to assess and assist children who may be in need of help and who qualify for interventions and modifications due to a disability. This includes students residing, or attending a private school, within the boundaries of one of these school districts. The rules or right which relate to the identification, evaluation or service of disabled students, are available to parents upon request. Parents, school staff or other may direct inquiries regarding any of the above information to the Director of Special Education of their local school district.
