Oregon English Language Learner Report 2015-2016 - data compiled by Oregon Department of Education

The <u>Oregon English Language Learner Report</u> is an annual publication required by ORS 327.016, which reports on financial information for English Language Learner programs and the objectives and needs to students eligible for and enrolling in an English Language Learner program. **Current** ELLs are students who qualified for English Language services during the 2015-16 school year. **Former** ELLs are students who did not qualify for English Language Services during the 2015-16 school year, but did in a prior year. This report provides information on the demographics of students in English Language Learner programs in each school district. In addition, this report provides a tool that makes data on English Language Learners accessible to researchers, media, students, and parents.

In accordance with ORS 327.016, the report must be provided to each school district board by September 1 of each year and made available at the school district's main office and on the school district's website.
