Chris Pash – Executive Director of Human Resources:

We are working on implementing a position control budget to improve transparency. Each position will have a single identifier to be able to run reports more efficiently. We are also cleaning up our data for the 80 day report. We have open enrollment for UNUM and NMPSIA this month. We are continuing to process new hires and substitutes preparing for the cold and

flu season. We currently have 382 substitutes on payroll. We are also making sure licensing is correct for teachers and other staff. This is 100 more substitutes than November 2019.

Bobbi Newland - Chief Financial Officer

The audit committee has scheduled an audit exit meeting for the 13th of November. The audit is due to the State Auditor on November 15th.

The Teacher Cost Index report was sent into PED on November 9th. This count is based on the 10/20/23 payroll. For 23/24 the TCI index is 1.046. Last year the TCI index was 1.060. The lower index will mean a decrease in funding for that portion of the district's SEG.
