# 5.0 <u>PUBLIC HEARING</u>

5A TEXAS ACADEMIC PERFORMANCE REPORT 2020-2021 (T.A.P.R)

Mrs. Lorena Ceballos reported that every year they get the district's annual report and one of the requirements is to conduct a public hearing to the Board of Trustees and the community. The district's annual report has seven sections and she reviewed what each of the following seven sections contained: 1) 2020-2021 Texas Academic Performance Report for the school district and each campus – This section contained the 2021 Accountability Rating – Not rated – declared state of disaster, 2021 Special Education Determination Status, 2021 Armed Services Vocational Aptitude Battery (ASVAB) Test, 2021 Distinction Designations, STAAR Performance report was cancelled, STAAR academic growth, Bilingual Education/English as a Second Language, STAAR participation, attendance, graduation, and dropout rates reported for the 2019-2020 and 2018-2019, graduation profile, college, career and military readiness, CCMR related indicators, other postsecondary indicators, student enrollment, staff information, and program information, 2) PEIMS Financial Standard Report (2019-20 20 Financial Actual Reports) for the district and each of the campuses for the 2019-2020 school year, 3) 2020-2021 District Accreditation Status – Student performance is a key indicator in the state accreditation system, TEA has suspended the assignment if accreditation statuses until the 2021-2022 school year; therefore, no district was assigned an accreditation status for the 2020-2021,

- 4) Campus Performance Objectives This includes the Campus Improvement Plans,
- 5) Report on Violent or Criminal Incidents on campuses TEA requires each school district to publish, as part of its annual report, a report on violent or criminal incidents that occur at each campus, 6) Student Performance in Postsecondary Institutions for each high school campus in the District TEA requires each district to publish, as part of its annual report, a report on student performance in post secondary institutions during the first year enrolled after graduation from high school, and 7) 2020-2021 TAPR Glossary The TAPR glossary provides definitions, describes methodologies, and lists sources for each data point in the

TAPR. A Spanish version of the TAPR Glossary will be available for release in late winter. The report is posted on the school district's website under the "News" link. Also, the information in the TAPR has already been presented to the Board.
