1. Introduction

Collin College has currently approved 5 projects that makeup this program, which will be managed by a third-party program management firm. The total budget for the 5 projects comprising this program is \$219,602,567.36. \$1,000,000 was moved from the Security Enhancements budget and \$1,000,000 from the 2 + 2 Academic Alliance budget to the Health Science project.

On February 27, 2024, the Board of Trustees granted the District President authority to enter into and negotiate a contract with AECOM Technical Services, Inc. (AECOM) to provide Program Management Services for the Collin College 2023 Master Plan Program. On May 3, 2024, Collin College and AECOM executed the Collin contract for program management services. As part of these services, AECOM will deliver a monthly report to provide status and progress of key aspects of the Program.

2. Executive Summary

Completed and Pending Items

- Plano Campus Roof replacement proceeding. PD 2 siding drywall. Area J and K drywall being installed. Racquetball Court framing in progress. Courtyard paving removal complete. Starting work in the theater.
- Courtyard Center First floor: Closing walls began and coring holes was completed. Second floor: onesiding walls began.
- CHEC Contract Amendment was executed and Purchase Order was issued to Skanska. Skanska has started mobilizing, setting up laydown yard with fence, and flooring protection on the first and second floor.
- Health Science Center Building Permit received from the City of Frisco. McCarthy continuing with
 onboarding of subcontractors and mobilization. McCarthy submitted their estimate for GMP 2. Project teams
 are vetting the estimate and schedule data.
- Wylie CTE Re-Programming, program layout and the general building layout approved on April 30th. 100% SD due May 30th.

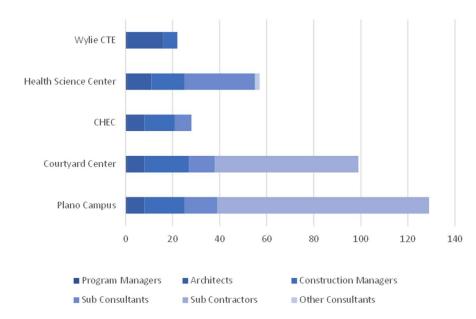
