SUBJECT: Open Enrollment Schools for the 2024-2025 School Year

Based on functional building capacities and student enrollment, the following schools will have an Open Enrollment status for the 2024-2025 school year.

<u>Elementary Schools</u> - Open enrollment will only be at the schools indicated in Grades 1 - 5 only unless otherwise indicated. Grade 6 will not be included for schools impacted by the boundary adjustments. Kindergarten will be determined after Kindergarten registration which will be completed in April.

Dates related to open enrollment are set within the parameters of the statute (Utah Code 53G-6-402). However, with the boundary revisions and opening of three new schools, timelines can be delayed due to a local school board not being able to make a reasonably accurate projection of early enrollment school capacity. The dates for 2024-2025 Open Enrollment Application will be as follows:

January 4, 2024 through February 23, 2024 –

Open Enrollment Application is available online and accepted at designated "open enrollment" schools during this application time frame.

Option #1: wsd.net – Parents & Students – Boundary Information Option #2: wsd.net – Departments – Student Services – Forms – Open Enrollment

A new Open Enrollment Application is required for incoming 7th and 10th grade students moving from elementary to junior high and from junior high to high school. Students are not guaranteed enrollment at the next level cone school.

MARCH 15, 2024 -

Withdrawal provision for students already attending under previous acceptance. The school will notify parents of students who will not be permitted to continue enrollment in the non-resident school.

MARCH 31, 2023 -

By this date, parent/student are notified of acceptance or denial, or within six weeks of the application whichever is later.
