# **SUMMARY:**

# **PREVIOUS BOARD ACTION:**

- Changes in Practice, including accepting evidence of speech proficiency for students in Strategic Learning for HS Math course, Texas First Graduation Plan, HB 3803/repeating courses options, and revised requirements for CCMR industry-based certifications
- Course Changes, including AP Precalculus (add), Earth Systems Science (add), Practical Math ALT (add), IB French HL Y2 (add), IB Math Analysis and Approaches HL (add), Math Models ESL (add), US Government ESL (add), US Economics ESL (add), Academic Competitions (add), Studio Art II Honors (sunset), Band Sub Non-Varsity B I-IV (add), Jazz Non-Varsity B I-IV (add), Art I: Art Appreciation (add), Technical Theatre: Advanced Costume III and IV (add), Dance I-IV: World Dance (Step Team) (add), Dance I: Dance Wellness/Dance for Athletes (add), Culinary Arts (title change only), Digital Art and Animation (add), AC/DC Electronics (add), Medical Terminology (add), Practicum in Animation (add), Practicum in Graphic Design (add), and Practicum in Audio/Visual Production (add)
