Title I: Academic Achievement

- WSISD has 7 Title I Schools (at or above 35% F/R)
- Title I Funds SUPPLEMENT (add to) and do not SUPPLANT (take the place of) local and state funds
- Title I funds may be used for children from preschool age to high school (ages 5-17 who meet a set criteria for being "at-risk"; or all students at a schoolwide campus)
- Must serve schools at or above 75% poverty (Liberty)
- Title I schools are served and funded in rank order of poverty

The primary purpose is to increase student achievement, with special attention to students and families who are most at-risk of not meeting standards of proficiency.

- Additional staff (teachers, tutors, assistants, & instructional coaches that support at -risk students)

*Because all campuses are Schoolwide status for Title I, we serve ALL "at-risk" students, including homeless students. Therefore, we do not reserve additional funds for homeless students.

- Developing leaders and mentors







- Supplemental Professional Development
