Re: 2013-14 Proposed Calendar

Date: Jan. 3, 2013

Please find attached the proposed calendar for the 2013-14 school year. In attendance at the December 19, 2012 meeting to discuss the same were: Peter Traczyk, Dr. Roberts, Lisa Schwartz, Jason Gold, Lee Ann Roskopf, Monica Madan, Todd Fitzgerald, Angela Dolezal, and me. Each of the District's collective bargaining units were invited to send representatives to the meeting.

Some features of the proposed calendar:

- At the time of our meeting, OPRF High School had not yet set its calendar for 13-14. The proposed calendar for Oak Park 97 aligns spring break and winter break with the other feeder elementary school district to OPRF, District 91.
- The committee was interested in moving the typical celebrations of three (3) holidays, Veterans' Day (Nov. 11), Lincoln's Birthday (Feb. 12), and Pulaski Day (first Monday in March) to days that are immediately adjacent to other holidays (or in the case of Lincoln's Birthday, adjacent to a weekend). Recent revisions to the School Code permit Board of Education to commute the celebration of five (5) holidays without the necessity of obtaining a waiver from ISBE.¹

Commuting the holidays to non-typical days will require the Board to conduct a public hearing regarding the same before adopting the calendar, and require that the person(s) honored by the holiday be recognized through instructional activities conducted on the day of the typical celebration (or the first student attendance day before that date, if the typical day of celebration is a day of no student attendance).

The committee recommends ...

o that Lincoln's Birthday, Tuesday, February 12, be moved to the day designated as President's Day, **Monday, February 18, 2014**².

The District has celebrated this February holiday as "President's Day" for the past several years, based on a waiver obtained from ISBE. Obtaining a special waiver for Lincoln's Birthday is no longer required, but the procedures described above will need to be engaged to move the date from Feb. 12 to another date.

o that Veterans' Day be moved to the Wednesday immediately preceding Thanksgiving Day, November 27, 2013³.

Having the day before Thanksgiving off in 2012 was very popular with our students and employees. Moving Veterans' Day, one of the holidays expressly identified in each of the District's labor agreements, permits Nov. 27 to be a day off for all employees of the school district without adding an additional holiday to the calendar.

In connection with Nov. 11, it is recommended that a Teacher Institute be conducted that day. Nov. 11 will then be a day of no student attendance, but the rest of the employees will be present that day.

o that Pulaski Day be moved to **Friday, March 21, 2014***, the Friday immediately preceding spring break.

Alternatively, the committee recommends that Pulaski Day be moved to **Monday, April 21**, the day after Easter, as spring break is not connected to Easter in 2013.

Similar to the situation involving Veterans' Day, moving Pulaski Day, one of the holidays expressly identified in each of the District's labor agreements, permits the day off for all employees of the school district without adding an additional holiday to the calendar. Also, it permits the District to use Monday, March 3 (the typical date for Pulaski Day) as a day for conducting ISATs, as well as avoiding conducting ISAT testing immediately following the students' return to school after a holiday.
