On Thursday, March 10, 2025, at 2:00 p.m., bids were received from seven (7) contractors for the 2025 parking lot project at Butterfield Elementary School. A bid tabulation is attached for your review.

Aztech Landscaping from Sandwich, Illinois submitted the low base bid in the amount of \$76,302.00.

Aztech Landscaping has informed us that they discovered an error in their bid and have requested the District allow them to withdraw their bid and have their bid bond returned per their attached letter. We believe it is in the best interest of the District to allow them to pull their bid from consideration for award.

The next low bidder is Schroeder Asphalt Services, Inc. from Huntley, Illinois with a base bid amount of \$909,000.00. We have conducted a post bid review with them to confirm that the project scope is sufficiently covered. Our recommendation is to award the contract to Schroeder Asphalt Services, Inc.

Our recommendation for award is as follows:

Allow Aztech Landscaping to remove their bid from consideration and return their bid bond. Award the contract to Schroeder Asphalt Services, Inc, in the contract total amount of \$909,000.00.
