July 15, 2014	Deadline to submit complete budget document to State Superintendent of Public Instruction and ESD superintendent. <i>ORS</i> 326.310(4)
August 15, 2014	Deadline for submission of the 200-10 electronic budget to the Department of Education. <i>ORS</i> 326.310(4)
September 4, 2014	First Day of School for Students
November 18, 2014	REGULAR BOARD MEETING. Approve a budget calendar to guide administrative staff and district in compliance with local budget laws.
December 29, 2014	Deadline for 2013-14 electronic Actual revenues and Actual expenditures to the Department of Education. ORS 326.310(4)
January 2, 2015	Last day to file the previous school year's audit with the Department of Education.

April 9, 2014	The earliest date that the first NOTICE OF BUDGET COMMITTEE MEETING may be published (not earlier than 30 days prior to the first meeting, nor later than five days before.)

April 21, 2015	REGULAR BOARD MEETING; Budget Officer presents updated forecast.
April 27, 2014	The earliest date that the proposed budget document may be released to the budget committee members and, therefore, the general public. (Not more than 10 days prior to mtg)
April 30, 2014	The latest date that the second NOTICE OF BUDGET COMMITTEE MEETING may be published
May 7, 2014	<ul> <li>FIRST MEETING OF THE BUDGET COMMITTEE. Elect presiding officer. June 16, 2015	PUBLIC HEARING ON THE BUDGET, as approved by the budget committee, shall be conducted by no less than a quorum of the board. ORS 294.430
June 16, 2015	REGULAR BOARD MEETING. Enact resolutions adopting the budget, making the appropriations, categorizing and declaring the tax levy. <i>ORS</i> 294.435 and oar 150-294-435
July 15, 2015	Deadline to certify the tax levy to the county assessors on form ED-50 and submit complete document to ODE.
