We qualify as 100% free and reduced lunch due to the extreme poverty and unemployment rates we experience. Last year, we identified #300 students as experiencing homelessness and an additional #150 as being raised by grandparents. |
| AboutNeed | At present, the largest issue affecting our schools and community is the rampant use of drugs and alcohol. In 2018, 50% of babies born were drug-exposed. This issue has contributed to an increase in the number of grandparents raising their grandchildren and students experiencing homelessness. Last school year, nearly 25% of our students experienced this type of instability. |
| About Families | Our district is requesting the full grant amount of \$2,500 to purchase new shoes for students being raised by grandparents. We will need to purchase at least #150 pairs of shoes at \$30 each for a total of \$4.500. We will request from our Tribal council to match this grant, if awarded, in an effort to meet the remaining financial cost. |
