# Approval of Guaranteed Maximum Price for the Construction of Science Lab and Renovations at Evers Park Elementary School

#### **SUMMARY:**

This item requests approval of the Guaranteed Maximum Price submitted by Balfour Beatty for the construction of the Science Lab and Renovations at Evers Park Elementary School.

## PREVIOUS BOARD ACTION:

#### **BACKGROUND INFORMATION:**

The 2007 Bond Authorization included funding for the construction of a science lab and renovations at Evers Park Elementary School. A Workshop Session was held on November 8, 2011 and December 11, 2011 with the Board of Trustees to discuss the plans for construction.

#### **SIGNIFICANT ISSUES:**

The guaranteed maximum price (GMP) submitted by Balfour Beatty is \$1,515,797 including the base bid of \$939,350 plus alternates 1, 3, 4 and 6 totaling \$576,447.
