The contract reflects Vocational Rehabilitation's agreement to pay for ½ of our transition coordinator's salary and ½ of the transition duties of our new teacher at THS. It works out to be 25% of the salary. A transition coordinator and teacher who does transition generally work with the goals and activities that allow a student to successfully transfer into their next job or setting after high school.

The first contract is for them to pay 50% of the salary for our full time transition coordinator. The second contract is the one where they agree to pay 25% because the transition component of that position is 50% transition and 50% teaching. They will pay 1/2 of the transition component which works out to be 25% of that person's salary.

The first contract is for a transition coordinator and the second contract is for a transition teacher.
