# **Analysis by Utility Type**

#### **Electricity:**

- Unit cost (rate) increased 4.8%
- Consumption <u>decreased</u> by 4.8%
- 3.7% less cooling degree days
- Net increase in dollars of \$32,138

#### **Natural Gas:**

- Unit cost (rate) increased by 3.6%
- Consumption increased by 22.0%
- •44.9% more heating degree days
- Net increase in dollars of \$41,843

# **Analysis by Utility Type**

#### Water:

- Domestic Unit cost (rate) decreased 0.1%
- Domestic consumption increased 3.8%
- Irrigation Unit cost (rate) increased 9.7%
- Irrigation consumption <u>decreased</u> 21.0%
- Rainfall increased by 61.3% / up 5.36 inches
- Domestic net increase in dollars of \$11,618
- Irrigation net decrease in dollars of \$52,260







From last reporting period rates increased 5% for domestic and 9% for irrigation meters.







## **Recent Activities**

- Detected and fixed water leaks at Calhoun, Evers Park and ATC
- Evaluated low energy use at Hawk and determined the utility electric meter was off
- Presented thermal storage (peak load shifting) opportunity to DME
- Evaluated demand response opportunities at Oncor served schools
- Currently evaluating LED lighting proposal at Denton Guyer

## **Current Recommendations**

- Move forward with implementation of bond energy and water projects
  - Exterior Lighting \$335,606; SPB 5.4 yrs
  - Intelligent Irrigation \$1,210,980; SPB 8.2 yrs
- Building Performance Management (BPM) pilot Project for 10 schools
  - Project Cost \$80,000
  - Annual Net Savings \$34,000
  - SPB 2.35 years
  - Option to pay initial cost over 3 years with positive cash-flow
