Motion was made to authorize Superintendent, Business Manager, or Administration to approve purchase orders within their budget and as per Minnesota Statutes, section 123B.52, subd.2. M/S/C Barsness/Fletcher, 7-0

Motion was made to authorize Business Manager and Bookkeeper to make electronic fund transfers. M/S/C Lewis/Quam, 7-0

Motion was made to authorize Board Chair Karla Bauer to appoint school board committee members for board approval at the January 25, 2010 regular school board meeting. M/S/C Lewis/Quam, 7-0

Superintendent Evert informed board members he would like have a MSBA retreat as newer members on the board have not gone through that process. He also encouraged board members to attend the annual 2010 MSBA Leadership Conference in Minneapolis on January 14-15.
