Ms. YellowOwl asked Ms. Campbell to explain, students driving to school. Ms. Campbell stated that they are going back to the handbook and the biggest issue was the drivers license, a student with a permit think that it gives them all the driving privileges which they are having to reference the law. This has cut down on students skipping and leaving campus. It is a lot safer; it is not 100 % to where we need to be but it is progress. She also stated that we need to ensure the safety of our staff and students. Superintendent Rappold stated that it is board policy and is in the student handbook which are aligning to implement the procedure.

## SUPERINTENDENT UPDATE

**Superintendent's Report**: Superintendent Rappold stated that we did finalize the fiscal year 2022 audit, we have received the audit report and has been reported to the federal government. She did follow up with

Wipfli for the 2023-2024 & 2025 they did come back with some parameters but bot a contract itself. They are willing to take us on if we agree to meet and date windows that they set for us for providing documents. She also stated that we should be able to meet them with the contract we have on the agenda to hire Gwyn Anderson, that would be one of her primary focuses to pull scan and send the documentation in the timeline Wipfli is expecting it.

Superintendent Rappold stated that the next few months we will be working on the implementation of the strategic plan. As well as looking through facilities to update the 20-year master plan. We will also be brining back some new policies to the board from the legislative session.

HR Status Report: Elementary level we need a PCA, TA, sped teacher, dean of students. High School we need and ELA reading interventionist, TA, math teacher, hi-set tutor. Food Service we need an assistant cook BHS; assistant cook for the supper program. Special Services we need and adaptive phys. ed teacher, special services nurse, school phycologist, couple speech pathologists. Transportation is in need of 4 9-month bus drivers. Ms. Sinclair also stated that we received some information from Mr. Bullcalf, that if CDL drivers receive their CDL designation before a certain year they will not be required to take a training course before testing for the S endorsement. Mr. Bullcalf is hoping that this will help with the recruiting process.

Coaching Update: Superintendent Rappold stated that there are a few openings. We speech & debate opening, soft ball, one assistant basketball opening, a band and choir director as well as a few middle school positions.
